DOMINION no longer requires the personal data for processing purposes, but you need it to present, pursue or defend complaints. You oppose processing whilst the legitimate reasons of DOMINION overriding your entitlement are being verified □ Data Transfer Right: You will be entitled to receive the personal data you made available to us in a structured, commonly used and machine-readable format, and also to forward it on to another data controller without DOMINION being prevented from doing so. You are also entitled to request that we disclose your personal data directly to another data controller whenever it is technically possible. Nevertheless, you will only be entitled to this right when we are processing your personal data pursuant to your consent or we are processing your personal data pursuant to a contract entered into with you and processing is automated. □ Right to object: You are entitled to request that we stop using your personal data, e.g. when you believe the personal data we possess about you might be incorrect or you believe we have no further need to use your personal data. If we process your data for direct marketing purposes, you are entitled to oppose this, including profiling, insofar as it is related to direct marketing. To this end, you are entitled to exercise this right or to request that we stop sending you marketing messages by opting out or unsubscribing in any marketing email that we send you. You are entitled to oppose at any time - for reasons relating to your specific situation - in relation to any processing of your personal data performed with our "legitimate interests" forming the legal basis, whenever you believe that your entitlement overrides ours. Having said this, DOMINION we can continue to process your personal data if we can justify that we have an overriding legitimate interest or that DOMINION we need to process your data to present, pursue or defend complaints □ Entitlement to not be subject to automated decisions based on the processing of your personal data, including profiling: You are entitled to oppose being subject to a decision that DOMINION. makes based purely on the

automated processing of your data and with no human involvement. However, you are only entitled to this right if this decision is legally binding on you or otherwise significantly affects you. If you have been subject to the aforementioned type of decision but disagree with it, you can contact DOMINION and request that



we review this decision, seeking human action, express your point of view or oppose the decision in any applicable way. You are not entitled to oppose an automated decision when: i) It is required to enter into or perform a contract with you, ii) It has been authorised by Law and appropriate measures are in place to safeguard your rights and privileges, or iii) It has been made with your express consent.
